Re: Official Residency Challenge to Candidate Lee Heard Tucker

Dear Ms. Tarpley:

I am writing you today to officially challenge the residency of a recently qualified candidate Lee Heard Tucker for Post 1 in the 2021 municipal election for the City of Johns Creek (Exhibit 5). The challenge is based upon a sincere belief that this candidate for office has not been a resident within the City of Johns Creek for one year prior to the upcoming election date for the 2021 municipal election and consequently is not eligible to stand for election under our city and state laws.


Ms. Tucker's residency is hereby challenged. This challenge is based, in part, on the following facts:

- It appears that Ms. Tucker purchased a residential property at 10388 Haynes Bridge Road (also referred to as 10388 Royal Terrace), Johns Creek, Georgia 30022 on or about June 15, 2020 (Exhibit 1).
- Based on public records, it appears that this property is owned by Lewanna Heard Tucker. She appears to have not obtained or applied for a City of Johns Creek Homestead Exemption since the acquisition (Exhibit 1). It is common practice to obtain a Homestead Exemption on a person's primary residence as soon as possible. Further, failure to obtain a Homestead Exemption is a strong indicator that a homeowner could have a primary residence in a different jurisdiction where a Homestead Exemption is currently held. Similarly, Homestead Exemption is specifically mentioned in O.C.G.A. § 21-2-217 (a)(14) as a basis to determine residency.
- Ms. Tucker's continued use of an address outside the City of Johns Creek on her driver's license further contradicts her assertion of residency (Exhibit 2). O.C.G.A. § 40-5-33 requires a change of a resident's address occur within sixty (60) days of moving from that location. Changing one's address with the Department of Motor Vehicles is a very simple and easy process. Given Ms. Tucker's assertion that she will have lived within the City of Johns Creek for at least one year prior to the 2021 Municipal Election, it seems odd that she would still maintain an address on her driver's license of 3110 Garden Walk SW which is within the City of Atlanta.


- Ms. Tucker appears to have **on at least three occasions within the previous twelve months**, voted in elections utilizing a precinct and resulting ballot that coincides with the City of Atlanta address (Exhibit 3). As you know, voting within the wrong jurisdiction is a violation of Georgia law per O.C.G.A. § 21-2-417. Similarly, the precinct in which one votes is considered a very strong indicator of their primary residency. This is because one affirms each time that the information one provides in exchange for a ballot when voting is his or her true and correct address of residency (Exhibit 7). Ms. Tucker voted no less than three times in the past twelve months where she attested to and voted ballots for precincts inside the City of Atlanta and not the City of Johns Creek (Exhibit 6), where she now claims residency during the same period. These two facts cannot coincide. The votes in question appear to be cast in the August and November 2020 elections and again in January 2021 election. All three dates seem to occur after Ms. Tucker supposedly established residency within the City of Johns Creek.
- An additional indicator of when Ms. Tucker intended to move her residency is substantiated by when she appears to have changed her voter registration information to establish herself within the City of Johns Creek (Exhibit 4). This change of address appears to have occurred on or around June 24, 2021, which is well within the one-year requirement for establishing residency within the city.

It is my understanding that Georgia law has many factors that determine one's residency. See O.C.G.A. § 21-2-217 for the exhaustive list. Clearly a person who legally states their residency is within the City of Atlanta on at least three separate occasions, all of which occur over a period of within the one year that they are required to live within the City of Johns Creek prior to the municipal election in which they are qualified to run for said office, combined with a driver's license address that matches the address attested to which the votes within the City of Atlanta were based on, is a strong indication that either (1) illegal voting activity occurred or (2) that the residency has not been established for one year prior to the 2021 City of Johns Creek Municipal Election. In either event, please accept this as an official challenge to Ms. Tucker's residency and eligibility to stand for election to the City Council of Johns Creek for this 2021 Municipal Election Cycle. Should you require any additional supporting information, please do not hesitate to contact me as it is imperative that the law is upheld and that the elections in this city and this state are conducted with the integrity the citizens deserve.

Thank you for your diligence in reviewing this challenge and for your service to the citizens of the Johns Creek.

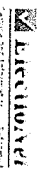

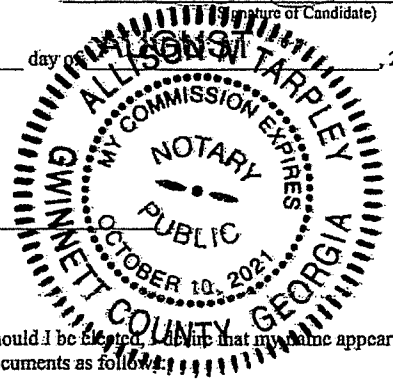
