NARRATIVE #1

On 04/22/2022 Deputy Cravey recieved a call in the lobby in reference to stalking.

Upon arrival Deputy Cravey spoke with a female identified as Kandiss Taylor who stated Neil Singleton was stalking her and making rude threats towards her and her children. When I asked Mrs. Taylor what she meant by threats she stated he was contacting the Appling County Board Of Education about her records and posting them online for others to see what her salary was and to show what her abscent leave was.

Mr. Taylor stated she blocked Mr. Singleton on all social media platforms and due to her blocking him he has now began threatening her child by posting pictures of him dressed up like a football player from when he was 8 years old. Mrs. Taylor stated that Mr. Singleton has made threats to show up to her campain events multiple times and cause issues. Mrs. Taylor stated he has not showed up any of the times but continues to post and make threats to do so.
