Re: Request for Production of Records & Reports Pursuant to the Georgia Nonprofit Corporations Code, Formal Audit Request

Dear Mr. McKoon,

As stated in the Rules of the Georgia Republican Party, Inc., a Title 14 nonprofit corporation commonly known as the Georgia GOP, I am a member by the effect of my standing under all four categories of solicited member: voter in precinct caucuses, elected Precinct Chairman, elected delegate of Fulton County, Georgia's 7th Congressional District, Georgia (State), and elected member of the Corporate State Committee (Membership Rule 1.1). Therefore, as such, I request the production of documents per my rights enumerated in Georgia Nonprofit Corporation Code, Chapter 3, Article 16, Parts 1 and 2.

Pursuant to O.C.G.A. 14-3-1602 (a)(2), I request production of bylaws currently in effect for the Georgia Republican Party, Inc. Pursuant to O.C.G.A. 14-3-1602 (a)(7) I request production of the names and home or business addresses of all current GRP, Inc. directors and officers.

In addition, pursuant to O.C.G.A. 14-3-1602 (c)(3) I request production of the current membership list of the GRP, Inc., in alphabetical order by class per O.C.G.A. 14-3-1601 (c) including all categories of statewide members defined in GRP, Inc. Rule 1.1 compiled no earlier than the date of this letter per O.C.G.A. 14-3-1603 (e).

Finally, a noprofit corporation shall maintain appropriate accounting records per O.C.G.A. 14-3-1601 (b). As such, I ask that you provide the date of the IRS letter granting the

Georgia Republican Party, Inc. a distinct Federal Tax ID (FEIN). Since the GRP, Inc. has claimed to be a state political party in federal court (twice in 2020), it must file all of its receipts for donations with the FEC. As such, I request records of all receipts for donations from February 1, 2023 to the date of this letter per O.C.G.A. 14-3-1602 (c)(2). Also, I request that you provide me with the most recent corporate financial audit report.

If you cannot locate a recent audit report, this letter shall serve as a request for a formal audit that covers the period January 1, 2020 to the date of the commencement of the audit. In the spirit of conducting a successful and transparent 2024 election cycle, I request that you commence an independent audit immediately, but no later than May 1, 2024, with a firm having absolutely no conflicts of interest with the Republican or Georgia political apparatus and capable of completing service within a 90-day period.

So that I may have full knowledge of those involved with completing this production request, I ask that you provide me the list of all affiliated corporations with whom you conduct the nonprofit business of the GRP, Inc. and the name of the specific entity for whom Karen Hentschel and Travis Bowden work as corporately paid staff. Who pays their salary?

As a nonprofit Georgia corporation formed in 2014 with the Office of the Georgia Secretary of State (Corporations Division), the Georgia Republican Party, Inc. is obligated to produce all of the above records within five business days of your receipt of the request pursuant to O.C.G.A. 14-3-1602 (b) and 14-3-1603.
